Dear Resident,

I'm writing to introduce myself and tell you a little about some changes being made around building safety. I am the building safety manager for your building, and you can contact me if you would like to talk about any building safety issues or concerns.

You may already be aware that you live in a high rise building, which means that it's either seven storeys or over 18 metres tall. There's been some changes recently to make sure people who live in these buildings are kept safe.

From 1 October 2023 a new regulator, the Building Safety Regulator, was put in place by government. Their job is to help ensure that your building is safe and that we as your landlord, are doing everything we should to keep you safe in your home.

The regulator asked us to register your building with them by 30 September 2023, which we have done.
