Fire Incident - Update



Incident Summary

- Occurred on Thursday (21/11/2024)
 - Fire controlled within 90 mins
 - 35 people evacuated
 - 1 person arrested
 - Cannabis plants found
- Most investigations completed
 - Structural investigations underway
- Mandatory Occurrence Report
 - Issued to regulator (Amir BSM)

Findings to date

- Fire brigade visit
 - No further action taken to date
 - Awaiting report
- Structural Engineer visit
 - Flat inspection underway
 - No actions recommended to date
- Additional Reviews
 - Review of internal fire escapes
 - Spread of smoke

Initial building safety inspections based on EWS1 (Consolidated Advice Note) assessment methodology before PAS9980 guidance in January 2021

>> EWS1s issued for taller buildings

Subsequent assessment under PAS9980 methodology

>> Additional investigations

>> Intrusive surveys within flats

>> Scanning of individual flats

- Internal Investigations
 - Condition survey (inc. material finishes)
 - 2 weeks total
 - Week 1 survey
 - Week 2 make good and repair
- Scanning
 - External
 - Entire building including roof •
 - No residential access required •
 - Internal
 - Approximately 30 minutes per flat
 - Every room within property •
 - Laser point data not photos
 - Ideally vacant (once access granted) but not necessary
 - Appointments for every property •

- January April: Phase 2 investigations across scheme
- Project review and appraisal on next steps
